

Cardgames Hub Privacy statement

Cardgames Hub has created this privacy statement to demonstrate that we take your privacy very seriously. The following information outlines how we collect and distribute information on this website.

Purpose of Cardgames Hub Data Processing Cardgames Hub processes your data for the operation and management of cardgameshub.com, for statistical analysis, to monitor compliance with the general terms and game rules, and for the specific purposes outlined below.

Collected Data Cardgames Hub stores usage data that is either submitted by users to our system (such as account details) or is created and automatically stored by our system (such as IP logs or game updates), as well as manual notes added by customer service or developers to log account events.

Automatically Logged Information We use users' IP addresses as a tool for investigating server issues and for managing our website. IP addresses are also logged and used for security purposes and may be used in abuse investigations or to identify cheaters in the game.

Cookies Cardgames Hub does not use cookies to collect personal data. Cookies are used solely to facilitate user visits to Cardgames Hub, mainly by remembering which specific section the user wants to start their visit from or remembering the last login date so that Cardgames Hub can distinguish new users from existing users. A temporary cookie is also used to track the user's session. Without this temporary cookie (which is not stored after the user leaves the platform), the user would need to log in again on each page. Cardgames Hub users can disable cookies in their web browser (more information is available at www.allaboutcookies.org/cookies). However, this may make it nearly impossible to access many features on Cardgames Hub. When a Cardgames Hub user follows links to other web pages, those pages may install tracking cookies on the user's device. This is beyond the control of Cardgames Hub, and in such cases, the privacy policy of the respective page administrator applies.

Advertisers We reserve the right to use rough location data from cookies for the purpose of displaying and/or targeting advertisements, offers, and other marketing communications. We do not use unique device identifiers for advertising. No personal data is shared with advertising companies unless explicitly stated as part of a specific promotion, with the user's consent via an opt-in checkbox.

Registration Forms The registration forms on Cardgames Hub require users to provide contact details (such as their name, email address, and country). Contact details from the registration form are used to communicate with the user when necessary. It is in the user's best interest to provide reliable information, as this is also used to verify account ownership. The user's email address is used to send a verification email, Cardgames Hub newsletters, and information during events (for which one must sign up), password reminders upon request, inactivity reminders, subscription expiration reminders, order confirmations, and updates on changes to the terms of use. Demographic and profile data is only collected on Cardgames Hub with user consent. This information is used solely for internal purposes on Cardgames Hub, on an aggregated basis, and is not shared with third parties.

External Links The Cardgames Hub website may contain links to other websites. Cardgames Hub is not responsible for the privacy policies or content of these websites.

Uploaded Public Data Photos uploaded by users are assumed to be uploaded with explicit consent for usage. If you upload photos featuring friends or other third parties, you must ensure that such persons have agreed to the publication of the photo before uploading.

Other In-Game Data All other data that users directly or indirectly create or access within Cardgames Hub is considered in-game data and may be accessed and used by us for the functioning of the game, including investigations into cheating, fraud, or criminal activities. Unless ordered by a court, we will not share such data with third parties other than law enforcement, our system administrators, our legal representatives, and companies that develop or operate the game and have agreed to comply with our privacy policy.

Security Cardgames Hub has implemented security measures to prevent loss, misuse, and alteration of information. These measures include firewalls, physical security, and password protection.
